

**WE RESERVE THE RIGHT TO DENY ENTRANCE TO OR REMOVE ANYONE, AT ANYTIME, FOR ANY REASON**

--All users of the Range must be 18 years of age or 10-17 years of age and accompanied and supervised by a parent or legal guardian at all times.

--All users must have a signed waiver on file, users 10-17 years old must be signed by parent or guardian.

--Machine gun rentals are limited to persons at least 18 years of age and under the direct supervision of a Range Safety Officer.

--Persons that have been **convicted of a felony crime and prohibited from purchasing a firearm**, have been deemed mentally defective or are currently subject to a restraining order are not allowed to use the Range.

**\*\*No one under the influence of drugs or alcohol will be allowed use of the Range.**

--We recommend pregnant women do not enter the range due to possible lead exposure. Please consult your physician.

--MMS staff may inspect all firearms, ammunition, containers and equipment brought into the facility.

**\*\*Persons causing damage in the facility agree to be held financially responsible and will be asked to leave the range.**

--MMS shall not be held responsible for lost, stolen or unattended items or personal property.

--Personal firearms and ammunition may be used together however all rental firearms shall use Range ammunition.

**\*\*All firearms must be unloaded or holstered upon entering and exiting the range.**

--Be sure the gun is safe to operate. Ask the Range Safety Officer if you need help.

**\*\*Know how to use the gun safely. Ask the Range Safety Officer if you need help.**

--Use only the correct ammunition for your gun. Ask the Range Safety Officer if you need help.

**\*\*Loading and unloading of firearms and magazines is to be done on the bench at the firing line only.**

--Aluminum cased, armor piercing, tracer, incendiary or rounds containing steel cores are NOT allowed.

--Maximum of two people per lane is allowed.

**\*\*Participants must wear approved eye and ear protection at all times. Safety glasses and full coverage ear muffs.**

--No drawing from the hip or holster allowed.

--Cross lane shooting is prohibited.

**\*\*Cell phone or camera use including calls, texting and photography or video is strictly prohibited in the range.**

--Tobacco use, eating or drinking is prohibited in the range.

**\*\*No part of you may go forward of the firing line or down range.**

--All shell casings shall be left on the floor. If you drop something forward of the firing line notify a Range Safety Officer and they will assist you.

--Know and obey all range commands. Cease fire may be called by anyone who sees an unsafe situation that must be stopped. Fire, Make Safe, and Load are other commands.

**\*\*When the command "Cease Fire" is given, stop shooting immediately and remove your finger from the trigger.**

**Await further instructions from the Range Safety Officer.**

**\*\*If your gun does not fire, hold it pointed at the target for 30 seconds, remedy it if you are able, if not lay it on the bench and notify the Range Safety Officer.**

**\*\*Report any unsafe activity or conditions, accidental discharges or injuries to the Range Safety Officer no matter how minor they may be.**

--In case of Emergency or power outage, treat the situation as a cease fire command has been given and await further instruction.

--Always wash your hands and face upon exiting the range with D-Lead soap and cold water provided by the exit door.
